6. Institutional set-up for liquidity risk management:

The Liquidity Risk Management of the Company is governed by the Liquidity Risk Management Framework and Asset Liability Management Committee (ALCO). The ALCO has the overall responsibility for management of liquidity risk. The ALCO decides the strategy, policies and procedures to manage liquidity risk in accordance with the liquidity risk tolerance/limits approved by it. The Asset Liability Management Committee (ALCO), which is a committee of the Board, is responsible for ensuring adherence to the liquidity risk tolerance/limits as well as implementing the liquidity risk management strategy. The role of the ALCO with respect to liquidity risk includes, inter alia, decision on desired maturity profile and mix of incremental assets and liabilities, responsibilities and controls for managing liquidity risk, and overseeing the liquidity positions at an entity level.





Notes:

- a. The amount stated in this disclosure is based on the unaudited financial statements as at December 31, 2020.
- b. "Significant counterparty" is defined as a single counterparty or group of connected or affiliated counterparties accounting in aggregate for more than 10% of total liabilities.
- c. "Significant instrument/product" is defined as a single instrument/product of group of similar instruments/products which in aggregate amount to more than 10% of total liabilities.
- d. Total liabilities has been computed as sum of all liabilities (Balance Sheet figure) less equities and reserves/surplus.
- e. Public funds is as defined in Master Direction Non-Banking Financial Company Systemically Important Non-Deposit taking Company and Deposit taking Company (Reserve Bank) Directions, 2016.
- f. Short-term liabilities include short-term borrowings, current maturities of long term debts and current maturities of finance leases.
- g. Total borrowings include long-term borrowings, short-term borrowings, current maturities of long term debts and liabilities towards finance leases.
